Privacy Statement and the Data Protection Act 1998*

RGA Underwriting will treat all your personal information as private and confidential (even when you are no longer a customer), except where disclosure is made at your request or with your consent or where we are required by law to disclose;

We will hold your details for a maximum of 6 years.

We will use your information for the purposes of administration, to source your financial products, marketing, customer services, analysing your purchasing preferences, customer profiling and to obtain customer feedback.

Privacy Policy

Before using the RGA Underwriting website, you should note the following points:

In order to deliver an effective service to you, it is necessary for us to store personal information about you and/or your company.

If you register to use the RGA Underwriting website, in order to supply details for either insurance or assessment purposes, we will treat all information supplied to us in accordance with this document.

We will not pass on any details to any other organisation outside of the RGA group of companies without your express permission or unless we are required to do so by the law.

If you visit the RGA website, having been introduced to us by a third party website, then information supplied by you to us, may be passed on to the relevant third party only.

Our privacy policy does not extend to any third party websites that you might visit via our websites, or be directed to from our website.

All necessary information supplied to RGA Underwriting will be processed and stored on a secure server and may be used during future visits to the site to facilitate easy repeated use. The transaction process will use data encrypted using a Secure Socket Layer (SSL) session.

Note that some older versions of web browsers do not support this facility; therefore you should ensure that the web browser you use supports SSL, such as Internet Explorer, Google Chrome, Apple Safari or Mozilla FireFox for example.

Cookies
